Anju D. Jessani Starts Term as President of New Jersey Association of Professional Mediators



Anju D. Jessani of Clinton, New Jersey, has started her term (October 1, 2005 to

September 30, 2006) as President of the New Jersey Association of Professional Mediators (NJAPM). Previously, Ms. Jessani served as President-Elect and Accreditation Chair for the association.

NJAPM, with nearly 350 members, is the state's largest mediation organization, and the only New Jersey mediation association with its own accreditation process. Members of NJAPM come from diverse backgrounds and include attorneys, mental health professionals, accountants

and other professionals. The majority of members are either solo practitioners or work for small firms. As a result, NJAPM serves as the voice for professional mediators in the state. The organization has offices in Hillsborough, New Jersey.

Mediation is a court-approved process in which a trained neutral person, called a mediator, encourages and facilitates the resolution of a dispute between two or more parties. The framework provides parties the ability the opportunity to negotiate mutually beneficial agreements. Mediation is informal and non-adversarial, with the objective of helping parties reach a mutually acceptable and voluntary agreement. It is almost always faster and less costly than traditional litigation. According to Ms. Jessani, during her tenure she sees "fostering excellence

in the field of mediation and promoting mediation to the public as the preferred method of dispute resolution" as her twin goals.

Ms. Jessani succeeds Gale Wachs, Esq., APM of Bridgewater as President of NJAPM. Other officers for the 2005-2006 term include Anthony P. Limitone, Jr., Esq., APM of Morristown as President-Elect, Carl J. Cangelosi, JD, APM of Princeton as Secretary, Armand Bucci of Voorhees as Treasurer, and William H. Donahue, Jr., Esq. APM of Westmont as Vice President.

Prior to founding her mediation practice, Divorce with Dignity Mediation Services, in 1997, Ms. Jessani was a Vice President with JP Morgan, and a management consultant with Price Waterhouse. She has an MBA from the Wharton School (1983),

and a BA from Douglass College, Rutgers University (1979). She is an Accredited Professional Mediator (APM) by NJAPM, and is also an Advanced Practitioner with the Association for Conflict Resolution, reflecting her high level of training and experience in the field of mediation. She serves on the New Jersey Supreme Court roster of mediators for both family/divorce and civil/business cases.

Her interest in mediation arose from her own divorce through mediation in 1994. She is married to Erik Purasson. Together, they have two children, Tara, age 17, and Luke, age 7.
